Ontario Primary Care Performance Measurement Initiative Information Sheet

The Goal:

Health Quality Ontario (HQO) is collaborating with others through the Ontario Primary Care Performance Measurement Steering Committee to provide leadership on a coordinated and sustainable approach to measure and report on primary care performance.

Our objective is to determine what aspects of primary care performance are most valuable to measure on a regular basis and the data sources and infrastructure required. Agreement on these measures and support for their collection, analysis and reporting will drive system improvements, track the impact of policy changes and investments, and inform service planning, performance monitoring and quality improvement at the practice level.

Approach:


In 2012, HQO and the Canadian Institute for Health Information, in collaboration with their partners, held an invitational meeting of senior leaders from key primary care data partners and information users in Ontario. This meeting, the Ontario Primary Care Performance Measurement Summit, resulted in the preliminary identification of primary care performance measurement priorities in Ontario and commitment from participating organizations to engage in ongoing collaborative work on primary care performance measurement. To inform performance measurement efforts in Ontario, the meeting proceedings were widely circulated.

In addition, the 15 organizations represented on the Steering Committee circulated the primary care performance measurement stakeholder survey in spring 2013 to engage their members and solicit their views on the aspects of primary care performance that would be most valuable to measure. Informed by the Summit results and over 850 responses received from the stakeholder survey, the Steering Committee identified a set of measurement priorities for the Primary Care Performance Measurement Framework.

Next Steps:

Working groups will select specific performance measures corresponding to the measurement priorities and will recommend methodology and infrastructure for data collection, analysis and reporting. Over time, the framework will be revised in response to changing performance measurement priorities and enhanced data collection capacity.
