A Note from Our Co-Leads

Program Highlights

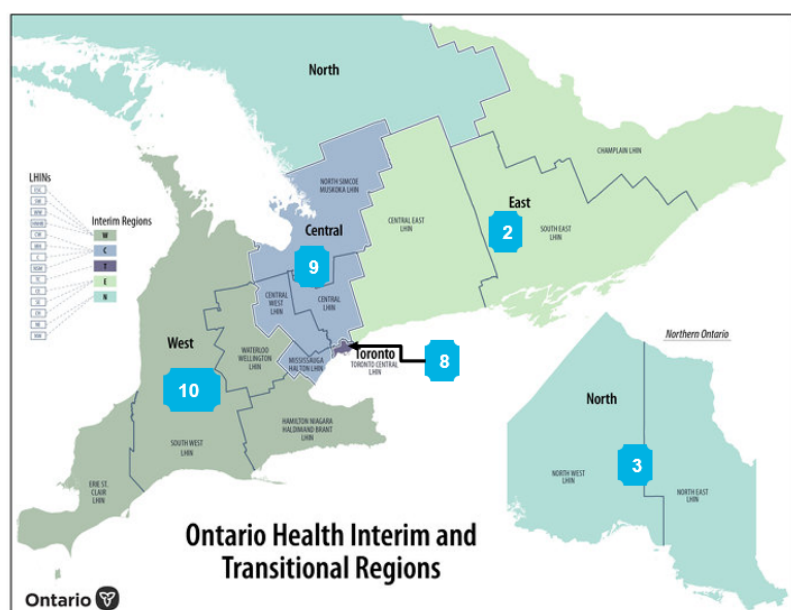


Figure 1: Map of GeMQIN Participating Sites as of July 2021. Click [here](#) for a full list of participating hospitals. Map adapted from the Ministry of Health: https://www.health.gov.on.ca/en/news/connectedcare/2019/CC_20191113.aspx

Almost one year ago, we set the goal of engaging up to 30 hospitals across the province to participate in GeMQIN and the COVID-19 Hospital Analytics Laboratory. Over the past year, clinical and operational leaders from 32 hospitals have joined our community to share evidence, experience, and inspiration from the front lines of the pandemic. Nearly all of the committed hospitals have now obtained the requisite research ethics board approval and data-sharing agreements to begin transferring data for quality measurement and research. Our team is working with the remaining sites to finalize their onboarding. With these 32 hospitals, approximately 55% of all general medicine patients in Ontario will receive care in a hospital participating in quality improvement through GEMINI/GeMQIN. See Figure 1 for a map of the participating sites. We are also pleased to share with you that 167 physicians at seven sites have received at least one [MyPractice General Medicine Report](#).

As we head into the summer and hopefully all have an opportunity to rest and recover, we want to express our sincere thanks for your contributions to this network over the past year. We are excited to work with you on the next steps in building a data-driven quality network. In the coming year, we will receive your hospital's data, prepare clinically meaningful quality reports designed by our community (thanks to those who have signed up for the report development committee), and initiate quality improvement initiatives.

Map of Participating Hospitals

March CoP Call: Delirium Quality Standard ([slides](#))

Dr. Amir Ginzburg and Mary-Lynn Peters from Trillium Health Partners and Dr. Don Melady from Mount Sinai Hospital shared their perspectives on delirium care in Ontario and its link to COVID-19 infection. Dr. Ginzburg described the challenges of identifying and managing delirium in acute care, while Dr. Melady provided an overview of the [Delirium Quality Standard](#), a tool that describes high-quality care for people with delirium. Ms. Peters provided insights on how the quality standard statements align with Trillium's Delirium Program, highlighting the positive impact of this program to Trillium's patients and providers.

June CoP Call: Palliative Care in General Medicine ([slides](#))

Dr. Darren Cargill, Provincial Clinical Co-Lead of the Ontario Palliative Care Network (OPCN), provided us with an excellent overview of the OPCN and current priorities, the important role it plays both within the context of COVID-19, and of palliative care more broadly. The mHOMR tool provides exciting opportunities to drive quality improvement in end-of-life care. Dr. Jonathan Ailon, Unity Health Toronto, described how mHOMR is being implemented at St. Michael's Hospital, Unity Health Toronto. [Managing drug shortages during a pandemic: tocilizumab and COVID-19](#)

(CMAJ) – Using GEMINI data, Verma et al. estimated the proportion of hospitalized COVID-19 patients who would have benefited from tocilizumab and anticipated a drug shortage during the pandemic's third wave. In collaboration with members of the Ontario COVID-19 Science Advisory Table, the authors demonstrated an approach to identifying drug shortages and proposed an ethical framework for allocation of scarce drugs.

[Lessons for hospital care from the first wave of COVID-19 in Ontario, Canada](#)

(Hospital Practice) – Ontario accounted for [approximately 40%](#) of all COVID-19 hospitalizations in Canada during the first wave and most COVID-19 patients were cared for on general medical wards. To support the COVID-19 pandemic response, GeMQIN pivoted, enabling accelerated sharing of COVID-19 experiences and learnings across hospitals in Ontario. This commentary summarizes key lessons related to hospital care of patients with COVID-19 based on experiences of GeMQIN members shared during our [October](#) and [November](#) calls.
